- Are you aware of what (the company) makes and the kinds of chemicals they handle? If yes, how did you get this information?
 Yes, Styrene. Materials were handed out by Ineos Styrolution.
- 6. Have you been given or heard any information about the kinds of risks or dangers they pose to the community in case of an accident? If yes, how did you get this information and when? Yes, in the hand-outs during the presentation and the site tour.
- Do you know what to do if you saw or heard what seems like an emergency or accident at (the company)? If yes, how did you get this information, and what would you do?
 Follow the emergency procedures / guides or hosts (as instructed on the orientation prior to entering the facility).
- 8. Do you know whom to contact in case you have any questions or concerns about (the company)?



Yes, individual is known.
