Chemicals management

In 2024, CIAC prepared and submitted **18 submissions** to the federal government on topics ranging from the updated draft state of per- and polyfluoroalkyl substances (PFAS) report to engagements on the implementation of the modernized Canadian Environmental Protection Act (CEPA). Modernization of CEPA included a new Plan of Priorities for assessing and managing substances, a Right to a Healthy Environment Implementation Framework, a Watch List for substances of potential concern and a targeted approach for managing high-risk toxic substances.

Climate change

CIAC engaged and consulted with the federal government on several initiatives outlined in their 2030 Emissions Reduction Plan. A heavy focus this year was on consultations for the proposed **Clean Electricity Regulations** (CER) and its impact on cogeneration facilities. Consultations continue for the proposed Oil and Gas Emissions Cap announced in November 2024. CIAC also provided feedback on the federal governments 2035 Emissions Reduction Target.

CIAC, Parliamentary Interns visit ERCO's Buckingham, Quebec facility

CIAC is a sponsor of the Parliamentary Internship Programme. This important initiative sees a dozen students from across the country spend time in Ottawa to learn about the workings of government and policy. On April 26, **ERCO Worldwide** hosted a group of parliamentary interns along with CIAC staff. The group had an opportunity to tour the facility — **which has been in Buckingham for over 100 years** — and learn how two important chemicals, sodium chlorate and sodium chlorite are made. The interns also witnessed first-hand ERCO's dedication to the ethic of Responsible Care and safety.



2025 Pre-Budget Submission to the Standing Committee on Finance

In August, CIAC submitted its Pre-Budget Submission to the Standing Committee on Finance. In the submission, CIAC outlined its recommendations for maintaining competitiveness and growing investment. This included: amending the Clean Manufacturing Technology Investment Tax Credit to cover the vital role of chemistry in critical minerals processing; derisking investments for circularity and more.

Canada's chemistry sector stands at the centre of the emerging hydrogen economy with important roles as a significant hydrogen producer, distributor and consumer — all in pursuit of a low-carbon economy. How are they doing this and what does it look like?

Hydrogen is often a co-product in the production of Canada's electrochemistry and petrochemistry industries. For instance, the production of chlorine and sodium chlorate, both used in the production of clean drinking water and forest products amongst other uses, results in the release of hydrogen from the electrolysis of water.

Andrea Khanjin**, Ontario Minister of the Environment, Conservation and Parks and MPP for Barrie-Innisfil speak at our 2024 Ontario Leadership Group meeting on April 10 in Toronto. During her remarks, Minister Khanjin noted that there is a collective responsibility to protect the health of Ontarians and the environment, and that environmental sustainability and economic growth are not mutually exclusive.

2024 Ontario Pre-Budget Submission

CIAC released its Ontario Pre-Budget Consultation submission January 10, which recognized the Ontario Government's regulatory efforts such as proposing to remove the restriction on carbon sequestration. CIAC recommended a coordinated effort to support the transformation of Ontario's chemistry sector to a circular plastics and net-zero carbon economy.

Jungbunzlauer announces \$200M investment

September 24, CIAC member **Jungbunzlauer** announced it will be building Canada's first xanthan gum facility — a **\$200 million** addition to the company's existing footprint in Port Colborne, Ontario. Ontario Premier Doug Ford, Ontario Minister of Economic Development, Job Creation and Trade, Vic Fedeli, Niagara South MP Vance Badawey and other dignitaries joined Jungbunzlauer site lead Ryan Doell in a special groundbreaking ceremony. The multi-year project is supported by \$4.8 million from the Invest Ontario Fund.





Evonik to invest \$9M in Maitland, Ontario facility

Evonik announced it would be investing **\$9 million** in their Maitland, Ontario facility on October 10. Along with creating new jobs, the investment will allow the company to expand the facility and purchase new equipment, which will be used to manufacture new grades of hydrogen peroxide, allowing the company to expand into other markets, in particular the electronics industry.

Submissions

In 2024, CIAC delivered three submissions to the Quebec Government: the 2024 pre-budget consultation in February; a submission on the Draft Strategy for the Reduction and Responsible Management of Plastics in Quebec (2024-2029) in February to the Ministère de l'Environnement, de la Lutte contre les changements climatiques, de la Faune et des Parcs; and a coalition submission in November on Bill 69, An Act to ensure the responsible governance of energy resources and to amend various legislative provisions.

Throughout the year, **Jean-François Fortier**, CIAC Regional Director for Quebec, Plastics, met with the following officials to discuss how the Quebec plastics industry can drive economic growth while promoting sustainability:

INC-4 and INC-5

In April, thousands of delegates and stakeholders from around the world descended on Ottawa for the fourth session of the Intergovernmental Negotiating Committee (INC-4) to develop an international legally binding instrument on plastic pollution. CIAC was at the negotiations providing industry insight following the proceedings.

For a small selection of coverage, see CIAC's Vice President of Policy Isabelle Des Chênes on CBC's the National April 23, in the Globe and Mail April 22, and in the Globe and Mail. April 22. Ms. Des Chênes also wrote an op-ed that was featured in the Hill Times on April 22: All eyes on Ottawa: the world comes together to address plastic pollution. Ms. Des Chênes also appeared in documentary about the negotiations on CBC Radio-Canada's French language program, Découverte which aired November 26. Watch the documentary here (in French only).

In November, Ms. Des Chênes and Vice-President of CIAC's Plastic Division, Christa Seaman travelled to Busan, South Korea for INC-5, which was to result in a final agreement. November 29, CIAC had an op-ed published in Sustainable Plastics Magazine, The path to a global treaty without duplication. Unfortunately, an agreement could not be reached, and plans are being developed for another session in 2025 to close the negotiations.

Save Plastic

2024 marks the third year of CIAC's public communications campaign known as Save Plastic. The campaign aims to educate the public about the role plastics play in a modern, sustainable way of life. Save Plastic focuses on industry innovations, recycling, product design, the development of a circular economy, and encourage real conversations among Canadians around the future of plastics.

In 2024, the Save Plastic campaign partnered with popular science influencer <u>Chemical Kim</u> who created accessible videos featuring plastics and how they are crucial to everyday life. 2024 campaign performance stats:

Operation Clean Sweep[™] (OCS)

In 2024, CIAC's Plastic Division successfully developed and launched the OCS Pilot verification protocol, completing the first of five planned on-site verifications. **Shannon Laszlo**, CIAC's Manager, Plastics Division Governance and Member Relations, represented CIAC at the inaugural OCS Con in Houston, Texas, where she moderated the panel on Holistic Resin Loss Prevention Throughout the Transportation Sector. The event was highly successful, and CIAC has been invited to participate in the 2025 OCS Con in Indianapolis, Indiana. Additionally, the majority of members with mandatory OCS participation are actively submitting self-reported assessments, and CIAC is working closely to support those who require additional assistance to ensure full engagement.

CIAC front and centre during unprecedented rail stoppage

After labour negotiations between Canadian National Railway, Canadian Pacific Kansas City and the Teamsters Union reached a deadlock, at 00:01 on August 22, shipments of goods in Canada by rail stopped. CIAC was front and centre in the media with numerous articles, television appearances on BNN, CTV and CBC, and op-eds in the Hill Times and Globe and Mail.

Events in the community

The first TRANSCAER event of 2024 took place on April 20 in Laurier Station, Quebec, where **75 first responders from seven municipalities** came together for an essential training session on railway safety and hazardous materials response. The event featured an informative presentation on railway operations, an in-depth exercise on critical documentation, and hands-on training with the CN Dangerous Goods Trailer. Responders from Dosquet, Joly, Laurier Station, Saint-Apollinaire, Sainte-Croix, Saint-Édouard, and Val-Alain benefited from the practical knowledge gained, which will enhance their preparedness for future railway emergencies involving dangerous goods.

In May, the TRANSCAER team held an event at the Canadian Emergency Response Contractors Alliance's Semi-Annual General Meeting in at the Saskatoon Fire Department Regional Training Facility. Thirty-nine instructors and volunteers were joined by 77 participants. Among those in attendance were representatives from Saskatoon Fire, Martensville Fire, Muskoday, Prince Albert Fire, Dalmeny Fire, GATX, Yorkton Tribal Council, SK EMO, Kawacatoose, SK Ministry of Highways, SK Public Safety, Day Star Band, Hafford Fire, Pasqua First Nation, Saskatoon Tribal Council, Carlton Trail Railway, Dundurn Fire, and SK Environment. One of the event highlights was a propane flaring exercise conducted under clear skies, making it an ideal setting for the hands-on training experience.

In 2024, the TRANSCAER team was pleased to host two events in British Columbia. The first took place in Abbotsford, B.C., in June, focusing on railway safety, tank car anatomy, TIH/PIH chemicals, and locomotive orientation. The second event was held in Kamloops, B.C., in September, where first responders participated in a classroom session followed by hands-on learning opportunities. This included rotating through hands-on sessions on tank car valves, hydrometers and flaring equipment, road trailer anatomy, and C Kits and railcar capping. Both events were well-attended by local first responders and industry professionals, who gained valuable insights into emergency preparedness and the safety measures involved in transporting dangerous goods.

Safety Train update

In 2024, the TRANSCAER team successfully completed the construction of the new Safety Train. Work began in July 2023, with significant progress made on installing valves and fittings on the tank car, as well as completing the platforms and structural components. After several years of careful planning, design, and sourcing materials, CIAC is excited to launch the new TRANSCAER Safety Train in 2025. The Safety Train will travel across Canada, stopping in communities where dangerous goods are transported, to raise awareness about rail safety and emergency response to transportation incidents involving hazardous materials. CIAC members and partners, as well as first responders will be able to request the Safety Train for events in their communities through <u>transcaer.ca</u>.
