## About Responsible Care®

For more than 40 years, Canada's chemistry sector has led the journey towards safe, responsible, and sustainable chemical manufacturing through its United Nations (UN)-recognized environmental, societal and governance (ESG) initiative, Responsible Care. Founded in Canada in 1985, Responsible Care is now practiced in **73 countries** and by **96** of the **100 largest chemical producers** in the world.

Through Responsible Care, CIAC members strive to the ethic to “do the right thing and be seen to do the right thing”. They innovate for safer and greener products and processes, and work to continuously improve their environmental, health, and safety performance.

## Responsible Care® Awards

In 2022, CIAC launched seven new Responsible Care awards. These awards supplement the existing awards under the Safety and Health Analysis, Recognition, and Exchange (SHARE) network and the Transportation Community Awareness and Emergency Response (TRANSCAER®) initiative, as well as the John Vincett Memorial Award and Responsible Care Verification certificates.

This awards program has been developed to recognize companies that exemplify leadership and outstanding performance based on the implementation and execution of Responsible Care over the past year. Through this recognition, CIAC provides its members and partners with opportunities to promote the Responsible Care brand while expanding business value.



## The goal of these awards is three-fold:

To inspire companies to practice and embed Responsible Care in their everyday business operations.

2

To highlight the ethic and principles of Responsible Care within the CIAC membership and promote the sharing of best practices.

3

To re-enforce CIAC's advocacy and visibility objectives.

# AWARD DESCRIPTIONS



## Operations Award

This award is meant to recognize a company or companies that have exemplified the Responsible Care Operations code. The Operations code describes the expectations for the safe and environmentally and socially responsible management of facilities and equipment operated by companies themselves or on their behalf by third parties. Winners will be honoured for their positive contributions in transportation, occupational health and safety, process safety, and/or resource conservation.



## Stewardship Award

This award is meant to recognize a company or companies that have exemplified the Responsible Care Stewardship code. The Stewardship code describes the expectations of companies to responsibly manage their products beyond their transport to the next entity down the value chain, the supply of raw materials and the sale of services and technologies. It also covers the development of new products and services and their transfer to operations and/or full commercialization. It expects a full understanding and appropriate management of the full life cycle of products, processes, and services. Winners will be honoured for their positive contributions in product stewardship, value chain stewardship, and/or research and development.



## Accountability Award

This award is meant to recognize a company or companies that have exemplified the Responsible Care Accountability code. The Accountability code addresses the company's relationships with stakeholders beyond those covered by the Operations and Stewardship codes, including the company's role in public policy development. It covers expectations for social responsibility beyond those aspects related to health, safety, and environment. Winners will be honoured for their positive contributions in community engagement and/or equity, diversity and inclusion.



## Company of the Year Award

The Responsible Care Company of the Year Award is CIAC's premiere honour and recognizes those member companies that have enhanced and embraced the Responsible Care commitments throughout their company. Winners of this award make Responsible Care synonymous with how they do business and exemplify components of all three Responsible Care codes.

# AWARDS DESCRIPTIONS



## OCS Company of the Year

This award recognizes a member's dedication, commitment and leadership in an industry that pursues environmental sustainability. The member demonstrates exceptional efforts and achievements in embracing our shared vision of a world with zero pellet, flake and powder loss.



## Jean Bélanger Award

Named after Jean Bélanger, the founder and "godfather" of Responsible Care, this award is meant to honour individuals who embody the same spirit and ethic that Jean Bélanger brought to life. This individual should reflect Responsible Care in all aspects of their life, not just in their work, and is based on both career and personal qualities.



## Women in Chemistry Award

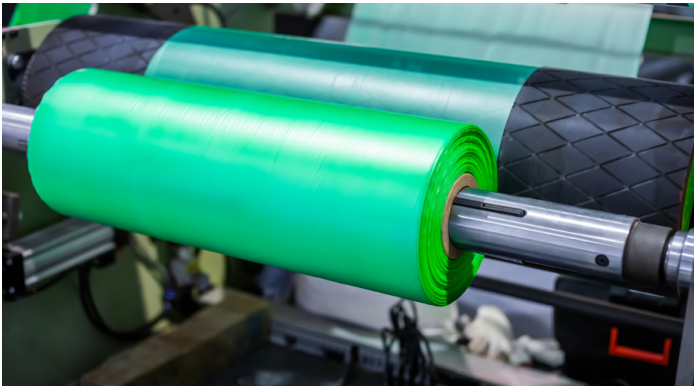
Women make up only a fraction of the workforce in science, technology, engineering, and math (STEM), and men vastly outnumber women majoring in most STEM fields in college and university. At CIAC, we want to create opportunities for women with talents and interests in science and chemistry to be recognized for their positive contributions and leadership. This award is meant to honour and recognize women who are seen to be leaders in the field of chemistry.



## Excellence in Partnership Award

Collaboration and partnership is key to the work that CIAC and our members do. Our partnerships are evident through our Responsible Care partners, as well as other industry, government, and non-profit partners who believe in and support the Responsible Care ethic. This award is meant to honour an implementation partner who has provided significant value to Responsible Care.

## Plastics Contributor of the Year

In recognition of significant contributions, demonstrated exemplary leadership, and a profound impact in the field of plastics. This award aims to celebrate professionals who have shown exceptional dedication, innovation, and commitment to the advancement of the plastics industry.



## President's Award

The President's Award is a discretionary award to recognize extraordinary contributions by CIAC member companies or individuals that advance the interests of the industry and CIAC membership at large.



# OTHER RESPONSIBLE CARE AWARDS

## SHARE Award

In 1997, CIAC's Safety and Health Analysis, Recognition, and Exchange (SHARE) Network established two awards to recognize outstanding safety performance among its member companies: "Excellence in Safety" and "Improvement in Safety". The purpose of these awards is to recognize companies demonstrating consistent improvement and excellence in safety and is based on results from the annual SHARE survey. ## TRANSCAER® Award

This awards program is designed to (1) recognize the achievements of individuals, companies, and organizations that have gone beyond the normal "call of duty" to advocate, demonstrate, and implement the principles of TRANSCAER; (2) enhance the public recognition of TRANSCAER; and (3) increase participation in the initiative.

## Responsible Care Assurance

As a condition of membership, companies are required to successfully complete CIAC Responsible Care audits every three years. The audits involve a thorough review of company management systems, along with interviews with leadership and engagement with local community stakeholders. A public report is issued outlining key findings, including best practices, opportunities for improvement, and any areas requiring corrective action. Companies are expected to share the audit results openly with employees and the communities in which they operate.

These stories may in turn be used in some of CIAC's advocacy pieces, such as the Annual Responsible Care Sustainability Report.

## Operations Award

- In 500 words or less, describe a Responsible Care story from your company that relates specifically to the Operations code.
- How does your company ensure that Responsible Care remains top of mind and is promoted by name in and around operations?

## Stewardship Award

- In 500 words or less, describe a Responsible Care story from your company that relates specifically to the Stewardship code.
- Please list your company's product stewardship goals and an action plan for meeting these goals. How do these goals demonstrate your leadership in product stewardship?

## Accountability Award

- In 500 words or less, describe a Responsible Care story from your company that relates specifically to the Accountability code.
- Please describe the processes through which your company ensures ongoing community awareness and dialogue. How do these processes affect and influence the way your facilities operate?

## Company of the Year Award

- In 1000 words or less, describe an initiative that your company has undertaken in the sustainability or continuous improvement areas.
- Provide a description of your company's participation in national or global Responsible Care activities.
- Describe the activities your company has engaged in to promote the Responsible Care ethic in communications to stakeholders, including non-traditional audiences. Provide a sample document or other communications vehicle that your company has used to promote Responsible Care.

## OCS Company of the Year

- In 500 words or less, describe an OCS story from your company that relates to the organizations journey to keep plastic out of the environment.
- How does the company ensure that OCS remains top of mind and is promoted by name in and around operations?
- How does the company ensure it clients and customers have the same commitment to keeping plastic out of the environment?

## Jean Bélanger Award

- Briefly describe the nominee's role at your company in relation to Responsible Care.
- What parts of the Responsible Care ethic and principles does the nominee exemplify? How do they exemplify these?
- Describe a time (personal or professional) when the nominee went against popular opinion or the "easy route" in favour of a decision that was the right thing to do.

- How has this partnership made a difference in advancing and supporting the Responsible Care ethic?
- Describe a time when you felt proud to have created this partnership through Responsible Care.

## Plastics Contributor of the Year

- In 500 words or less, describe innovative contributions or projects that your company/individual has been involved within the plastics industry.
- How has your company/individual influenced positive outcomes in the plastics industry?
- How does the company/individual integrate eco-friendly practices in your work within the plastics sector.
